## Successful Grant Recipients

The successful community organisations who have been awarded the Foundations 2012 community grants to benefit their communities are:

\$10,000 to the Boolarra and District Youth Theatre Company for an arts based youth education program culminating in the production and staging of "Boolarra in the Park" a Shakespeare style Midsummers Night Dream in Spring". This will provide the youth of the district with an opportunity to work with skilled professionals and develop a theatrical production.

\$5,000 to the Mirboo Recreation Reserve for the construction and installation of a much needed children's playground.

\$5,000 to Uniting Care Gippsland for theirprogram "Celebrating Youth Through Community Arts and Activities" at the Mirboo North Grainstore. This will involve young people in producing drums and skate boards they can use and exhibit.

\$3,000 to South Gippsland Primary Care Partnership auspiced by General Practice Alliance (GPA) South Gippsland for the "Act. Commit, Belong" (ABC) program. This campaign encourages and promotes good mental health in adolescents and has been a proven success in Western Australia.

\$5,000 to Mirboo North Secondary College for the Year 8 'Get Real' personal development program for students, that will have flow-on benefits across the school and broader community.





\$5,000 for Mirboo North Secondary College to enable students to participate in the 'Year 9 Community Break Out' program and strengthen the bond between students and community groups. This program won a Gippsland Curriculum Innovation Award in 2010.

\$3,200 to Dumbalk and District Progress Association for the purchase and installation of a community visual and audio system to assist the community to run training and other events.

\$4,000 to the Mirboo North Arty Gras Festival and Art Show (auspiced by Mirboo Country Development Inc) to enable the development and implementation of a joint media and publicity campaign to attract more visitors and enhance the social and economic outcomes for the district.

\$5,000 to the Mirboo North Walter J Tuck Reserve for an audio and sound system to provide improved facilities for training and events for the community and public, particularly for the local youth.

\$1,400 to the Mirboo and District Historical Society to relocate and preserve the old Police Lock-up in a prominent position for tourist, visitors and the community to enjoy and to preserve a piece of local history.

\$1,620 to Ridge Writers (auspiced by Mirboo Country Development Inc) to deliver a program of workshops for community members to encourage self-expression, personal development, selfdiscovery and empowerment.

\$2,145 to Mirboo North RSL for a new electronic step for the community bus to assist physically challenged users of the service.

### Mirboo North and District Community Foundation delivering the FRRR "2012 Back to School" program

For the first time, the Mirboo North and District Community Foundation will be partnering with the Foundation for Rural & Regional Renewal (FRRR) and Mirboo North Secondary College to support students through the "2012 Back to School" program. The "2012 Back to School Program" is a national program that provides \$50 Target gift vouchers for students in need.

FRRR has granted \$1,000 to the Mirboo North and District Community Foundation to provide 20 vouchers to students attending the Mirboo North Secondary College. These vouchers are redeemable for items such as school uniforms, clothing, shoes, school bags and stationery items. The program has been supported by various trusts and foundations, particularly the Sidney Myer Fund whose generosity, together with FRRR, has been the financial backbone of the program. The Mirboo North and District Community Foundation has supported the Mirboo North Secondary College over the past 2 years by providing grants to assist with the delivery of innovative programs that benefit the students and community.

Karen Lanyon of Mirboo North Secondary College said:

"These vouchers will be a major benefit to those of our students who require assistance in meeting the ever increasing costs of attending school and providing basic resources, enabling them to focus more directly on their learning and improving their participation in school life. We thank both Mirboo North and District Community Foundation and FRRR for their help in supporting our students".



## Sponsorship Grant

A Sponsorship grant of \$1,000 has been awarded to the Mirboo North Senior Citizens Centre Inc in supporting Senior Citizens to stay connected in their community by making transport available through the Mirboo North RSL community bus.

Gerry Rabach of the Senior Citizens Centre said "This sponsorship will mean that many Senior Citizens who are currently unable to partake in many of the Centres activities through lack of transport will now be able to do so and enrich their lives and enjoyment in the company of others".
